

## TORRINGTON BOARD OF EDUCATION SPECIAL MEETING – PUBLIC HEARING Wednesday, April 1, 2015 Torrington High School, 50 Major Besse Drive

## DISCUSSION: THS ADA SITE PROJECT

Mr. Bascetta handed out and explained two maps outlining the Torrington High School ADA Site Project – TMP 143-LKVC (final design as submitted).

Mr. Knight moved that the budget transfer request be granted. Mr. Thibault seconded the motion. All in favor.

Members continued reviewing a list of potential cuts. Ms. Aird presented information regarding Camp Moe.
