1. Call to Order: 6:00 P.M.

 - a. Mr. Kissko shared input from teachers with regards to the SBAC followed by a response presented by Superintendent Lubomski & Assistant Superintendent Fergusson.  - b. The committee discussed the summary of findings and next steps. The transient aspect of many students and impact on scores were highlighted at each school. Concerns over funding some of the areas in need of improvement and the upcoming budget season were expressed. Members would like to use information gained through this research to help with budget decisions. Low cost/no cost ideas were brought up including positive reinforcement for students. Superintendent Lubomski shared new initiatives that are in place. She stressed that time was needed to analyze progress before adding new initiatives and programs. The committee agreed to move some items designated areas of concern that have limited budget impact to the School Improvement Committee and to conclude the convening of the SBAC Ad Hoc Committee.

The members and Ms. Svetz-Juliano echoed thanks to Ms. Cappabianca and Mr. Kissko for all of their efforts in this project.
