Special Board of Education Meeting Expulsion Hearing- March 19, 2010

Mr. Oliver called to meeting to order at 1:05 p.m.

The proceedings were conducted in accordance with Section 10-233A-F of the Connecticut General Statutes concerning Expulsion and Suspension of Public School Students and in accordance with the Administrative Procedures Act, Section 4-176E of the C.G.S. and also conducted in accordance with the Board of Education Policy No. 6192 having to do with Suspension/Expulsion of Students.

Expulsion Hearing-Student A

On a motion by Mrs. Ellen Hoehne, with a second by Mrs. Heather Kosmulski, the Board of Education went into executive session to conduct a student expulsion hearing at 1:07 p.m.

The Board of Education recessed at 1:16 p.m. and resumed its meeting at 1:32 p.m.

On a motion by Mrs. Ellen Hoehne, with a second by Mrs. Heather Kosmulski, the Board of Education came out of executive session at 1:33 p.m.

On a motion by Mrs. Ellen Hoehne, with a second by Mrs. Heather Kosmulski, the Board of Education, moved that Student A be expelled from school and all school activities, including transportation privileges, until April 1, 2010, and in addition, shall perform community service for 1 hour per day until

the end of the 2009-2010 school year because it was found after the hearing that on about January 26, 2010 the student committed the following acts: he swore and threatened school staff members. It was further found that said student's acts on or about said date constitute a violation of the Torrington High School Code of Conduct, Section III, concerning respect and courtesy, and the Board's Suspension/Expulsion Policy No. 6192, providing that threatening staff shall be grounds for expulsion. It was further moved that the student be provided with an alternative educational program during the period of expulsion.

On a motion by Mrs. Heather Kosmulski, with a second by Mrs. Ellen Hoehne, the Board of Education adjourned at 1:35 p.m.
